

Reminder: For IHSS providers to paid get sick leave, you must work a total of 100 hours. Beginning July 1st, 2024 providers will have a maximum of 40 hours of sick leave available. Any unused sick leave will expire at the end of every fiscal year (June 30th), and providers will get new sick leave on July 1st.

Our Support Services Coordinator, Aurora, is available to assist Registry Providers with setting up Electronic Time Shift (ETS) and to help those who may need to recover their password if it has expired. Additionally, Aurora can refer Recipients and Providers to various community services in Marin County, including: Immigration, Legal Aid, Rental Assistance, Mental Health Services, Companionship, Daycare, and assist in enrollment for Cal Fresh.

A resource that is a new partner is LITA (Love is the Answer): LITA provides volunteers to isolated Marin County residents for connection and companionship to older adults.

Finally, congratulations to our provider Maria F, who is now a resident in the brand new Vivalon Healthy Aging Campus, with assistance from our agency throughout the process of qualifying for her new Senior Housing!
